The White Paper to follow the DCSF document *21st Century Schools: A World-Class Education for Every Child* was to have been published in early May, as indicated on the May Bulletin Board. Publication has been delayed until June.

4 Governance Review

In May's Bulletin Board, the indication was that the long awaited report on the Governance Review would be published at the same time as the White Paper (*item 3*). The draft report has been circulated to members of the Ministerial Group so publication in June seems a reality. The indication is that the consultation will be held in the Autumn – at last. We'll alert members to the report and consultation dates. *Please respond to the consultation, late as it may be!*

5 Meetings Digest

NGA Summer Conference: Leeds, 9 May 2009 – a report on, and presentations from, the event can be found on the NGA website via the attached link <http://www.nga.org.uk/may09.aspx>

National Heads' Children's Services Officers' and Governors' Group (HEG) (12.05.09):

Issues discussed included:

- *The STRB's proposed measures regarding Executive Head's contracts* were clearly interim and it was agreed that HEG members should lobby to ensure the issue was addressed properly as these posts grew in number;
- *21st Century schools:* NAHT had produced a document of all current and proposed initiatives, RAG rated for cost, workload implications and effectiveness. Particular concern expressed about workload, especially in regard to such things as reporting on behaviour partnerships, and complaints. It was determined that a jointly agreed complaints policy would be helpful;
- *SIPs:* it was agreed things were working better in the secondary sector where the SIP was less likely to be the link adviser as this confuses accountability. The SIP's brokerage role needed strengthening.

Toby Salt, Deputy Chief Executive, NCSL (14.05.09): Issues discussed included:

- *NPQH:* NGA expressed continuing concern about the quality of applicants (50% fail the pre-assessment module). It was agreed that NGA should be consulted on governance questions for the final assessment;

- *Training for Chairs of Governors*: It has been agreed that NCSL should work with DCSF and partners to help produce training for new chairs. However, funding, delivery and incentives have yet to be agreed. NGA wondered if there could be a role for Ofsted to ensure that governing bodies were trained;
- *National Standards for School Leaders*: It was agreed that the governance aspect of the standards remained problematic. The standards were due to be finalised this term, with the guidance completed next term. It may be that the governance aspect would be fleshed out in the guidance. NGA remained unsure that this was satisfactory and expressed concern that this was discussed at the Social Partnership to which NGA does not have access. It was agreed that NGA should be included in the relevant sub-group meetings.

Other May events or meetings attended by NGA representatives (or for which NGA provided chairs or speakers) included: Nick Gibb MP, Geoff Friston, DCSF Governance Unit (Honours for governors), SE COGS, Chris Keates, General Secretary of NASUWT, Buckinghamshire Governors' Conference, TDA Governors' Group, DCSF (Developing sex and relationships education guidance for schools, DCSF (Developing drugs and alcohol guidance for schools), NCSL (re. new remit for Children's Services Directors), School Food Trust Stakeholder Meeting, Christine Gilbert, Ofsted HMCI, Local Government Ombudsman, Foundation Trusts Governors' Association.

The School Staffing (England) Regulations 2003 have, over time, had a number of amendments made to them and in some places are written in a way that is neither up to date nor helpful to the end user.

Therefore, in order to make necessary changes which will bring the Regulations up to date with current legislation and reflect what is required by new policy the DCSF is carrying out a consolidation and redrafting exercise. In accordance with Government policy, DCSF now wishes to consult formally with interested parties on this consolidation exercise.

9 Curriculum Reform (of the Primary Curriculum)

The DCSF is proposing to reform the primary curriculum, following the publication of the independent review of the primary curriculum by Sir Jim Rose; revising the legal requirements for personal, social, health and economic education, following the publication of Sir Alasdair Macdonald's review of personal, social, health and economic education; updating the National Curriculum subject level descriptions; and updating the religious education guidance. As governing bodies are responsible for monitoring the curriculum, their views are important and account will be taken of these views. *The QCA has been asked to carry out this consultation, which is to be found on its website. Responses are invited online, but it is possible to download the material, print off and post it to QCA.*

11 Handling Allegations of Abuse made against Adults who work with Children and Young People

Following the review of the implementation of guidance on handling allegations of abuse against those who work with children or young people, the Government made a commitment to publish additional practice guidance. This is supplementary to the guidance contained in Appendix 5 of *Working Together to Safeguard Children* and Chapter 5 of *Safeguarding Children and Safer Recruitment in Education*. It sets out the statutory framework and underlying principles of handling allegations of abuse for those involved in dealing with allegations. It covers practical issues surrounding exercising professional judgement, information sharing and record keeping. It also explains the allegations process through to referral to the Independent Safeguarding Authority.
